Informational - Steps & COLA

- The Governing Board approved the FY 2016-2017 budget on a 4-3 vote, which include salary increases.
- The salary adjustments include a step for all step-eligible employees or 2% COLA adjustment for those employees who are currently at the top of the pay scale ("stepped out").
- Employees Eligible for a Step
 - Employees working as of June 18, 2016 that are step-eligible will receive one step
 effective July 2, 2016. Employees who currently fall between steps will receive the
 equivalent of a step increase.
- Employees at Their Top Step
 - Employees working as of June 18, 2016 and who are at the top of their respective scale will receive a 2% base salary increase effective July 2, 2016.
 - o Those who are between the last two steps of their respective scale will receive the top step or a 2% base salary increase, whichever is greater.
- Employees Above Their Top Step
 - Employees working as of June 18, 2016 and who are currently above the top of their respective salary schedules will receive a 1% base salary increase effective July 2, 2016.
- Adjunct and OYO/OSO Faculty
 - Adjunct Faculty and OYO/OSO faculty employed as of August 20, 2016 (first day of Fall accountability) will receive a 2% one-time payment based upon the total of their adjunct assignments. Adjuncts who continue service beyond the fall semester are eligible for additional 2% one-time payments for each term within fiscal year of 2016-17.
